On December 21, 2007, Medtech Products Inc. ("Medtech"), an indirect wholly-owned subsidiary of Prestige Brands Holdings, Inc., entered into two Contract Manufacturing Agreements with Pharmaspray B.V. for the supply of cryogenic wart removers.
